Funds Availability Policy Changes

When you make a deposit, the general policy of SCCU is to make funds from your cash and check deposits available to you on the same business day of or the second business day after the day of the deposit, depending on the type of deposit. In the event that we must hold funds, a portion of the deposit will be made available to you the same day of the deposit.



Our funds availability policy will be updated effective July 1, 2020. The changes are as follows: (1) You may withdraw the first \$225 of any deposit of checks, paper or electronic, on the same business day as the day of your deposit. This amount was \$200 previously. (2) You may withdraw up to \$450 of the deposit by cash or similar means on the SECOND BUSINESS DAY after the business day of your deposit if your check is a local check. This amount was \$400 previously. (3) For new accounts within the first 30 days,

the first \$5,525 of a day's total deposits of cashier's, certified, teller's, traveler's, and federal, state, and local government checks will be available on the first business day. This amount was \$5,000 previously.
