

### 67th Annual Meeting to Be Held February 18, 2021

Join us on February 18 for our 67th Annual Meeting! The meeting will be held at 6:00pm at The Christian Activities Center of the Gathering Church, next to SCCU's main office at 4503 Hixson Pike. Please check www.MySCCU.com or call (423) 875-6955 in February to see if there are any COVID-related changes for this meeting.

The Board of Directors shall consist of five (5) members of the Credit Union. At each annual meeting of the Credit Union two (2) or one (1) member(s) shall be elected to the Board of Directors for a term of three (3) years each, unless the election is to fill a vacancy, in which event, it shall be for the period of the unexpired term. Only Prime Share account holders (first name on the account) will be allowed to participate in this business meeting of the Credit Union. All eligible voters must be at least eighteen (18) years of age to receive a ballot.

One (1) Board position is up for election at this annual meeting. Any qualified member interested in being considered for this position may have his/her name placed on the voting ballot, either by petition or nomination by the Nominating Committee. All criteria should be submitted to the Nominating Committee as specified below.

#### Nomination by the Nominating Committee

The Nominating Committee will consider each resume and select the one(s) they feel would best serve our members.

#### **Nominating Petition**

You may have your name placed on the voting ballot by completing a Nominating Petition, which can be picked up at the main office of the Credit Union, 4503 Hixson Pike. The Nominating Petition must contain the signatures of at least 25 qualified members who are at least 18 years of age and in good standing with the Credit Union. The Nominating Petition must be submitted by 5:00pm on Tuesday, February 2, 2021 at the Credit Union's main office, 4503 Hixson Pike.




## A New Look for Online Banking and Mobile
