

## **Official Rules - NO PURCHASE NECESSARY TO WIN**

**SWEEPSTAKES PERIOD**: The Sweepstakes starts June 30, 2025 at 10:00 AM EST and ends on July 3, 2025 at 5:00 PM EST.

**ELIGIBILITY**: The SCCU Digital Days Sweepstakes is open to any Scenic Community Credit Union ("SCCU") member who has a primary share account, is a legal resident of the United States, and who is 18 years and older as of date of entry. SCCU employees and their immediate families (spouse, parents, children and siblings, and their respective spouses) and individuals living in the same household of an SCCU employee are not eligible.

Void where prohibited or restricted by law. All applicable federal, state, and local laws apply.

**HOW TO ENTER:** Participants may submit their entry as follows: Participants are asked to register for Scenic Community Credit Union Online Banking, stop by and meet at our booth, and be new to enroll in any of these services to qualify: eStatements, Bill Pay, Peer 2 Peer, Digital Wallet, Remote Deposit, Scenic Score. Any Scenic Community Credit Union eligible individual who is newly registered during a weekly promotional period as described above will be entered into the drawing. Alternate entries must be mailed on a plain 3.5" x 5" postcard. The entry must include (legibly hand printed or typed) name, complete address, city, state, ZIP code, phone number (including area code), and email address (if any). Mail your 3.5" x 5" postcard to: "Digital Days Sweepstakes" SCCU Marketing Department, 1058 PO Box Hixson, TN 37343.

**ENTRY REQUIREMENTS:** Limit one (1) sweepstakes entry per account. Additional entries received beyond the first Entry will be void. Participants may only win one (1) time. Once a participant is chosen as a winner, their entry will be removed from the sweepstakes. Must be first time enrollment for Online Banking, eStatements, Bill Pay, Peer 2 Peer, Digital Wallet, Remote Deposit, Scenic Score to qualify.

**SELECTION OF WINNERS**: The winning entries will be chosen based on a random drawing.

**PRIZES:** One (1) \$100 prize will be awarded, for a total of one (1) winner.

**NOTIFICATION:** Winners will be notified by e-mail, mail, or telephone. If prize notification is returned as unclaimed or undeliverable, or if a prize winner cannot be reached within 2 business days from the first notification attempt, then the potential winner may be disqualified, and an alternate winner selected. Winner may not transfer prize rights or obtain substitutions or cash redemption. The prize amount will be paid by deposit into members prime share account.

**ODDS OF WINNING:** The odds of winning depend on the number of eligible entries received. MISCELLANEOUS: By entering, each entrant warrants that SCCU and/or its designees may determine the winner without further consideration, notification, or permission of entrants.

**RESTRICTIONS:** The following are prohibited and will result in automatic disqualification from the sweepstakes: 1) using any method that artificially increases odds of winning, 2) non-compliance with these Sweepstakes Rules, and 3) any other act which SCCU determines that, in our sole discretion, jeopardizes the integrity or proper conduct of the sweepstakes.
